A stitching equipment company, Hohner Stitching Products, Inc., has signed a new lease for 5,300



square feet of flex space within 2521 Technology Drive in the Parke for its sales and showroom operations. This is a new area location for the firm which is based in Lee's Summit, Missouri. The firm selected Rogers Business Parke-Elgin for its proximity to Interstate 90 and available business amenities. Zannis of Arthur J. Rogers & Co. represented ownership.
